Our Response <p>The GLAA public register lists the labour providers who are licensed or who have applied for a licence. It will allow you to search at county level to provide you with a current list of licence holders. Filtering allows you to identify those registered in Cambridgeshire.</p> <p>The information in Table 1 lists the Cambridgeshire registered GLAA licence holders that have had a Compliance Inspection in the last 3 years. Table 2 provides the details of one Cambridgeshire registered GLAA licence holder whose licence was revoked.</p>

Under our duty to assist it may be helpful for you to know that the [2017 UK annual report on modern slavery](#) provides an overview of modern slavery in the UK and explains how the UK has responded to this threat over the last 12 months. This report also includes statistics and case studies of human trafficking and modern slavery.

The GLAA also recently published a [report](#) that outlines the nature and scale of slavery in the UK today - who is being exploited, which industries are affected, and the methods being used. This helps inform GLAA and partner agency decision making processes and focus resources on the areas at greatest risk both at strategic and operational level.

You might also be interested in the details of Operation Endeavour which was launched as a result of a joint agency campaign called Operation Pheasant. This began in early 2013 with the aim of tackling homes of multiple occupancy and poor living standards affecting economic migrants, mainly from Latvia and Lithuania, in the Wisbech area. Pheasant officers working with colleagues from Fenland District Council and the GLA to combat exploitation and associated crime in Fenland. The Op Pheasant team is seen as best practice for how to deal with trafficking and exploitation and is recognised by foreign embassies of Eastern European countries that have been affected. In [2016](#) four people were jailed for a combined total of more than 23 years for offences relating to the exploitation of migrant workers in Fenland. This also featured as a case study of the GLAA's work in our [2016-17 Annual Report and Accounts](#).
