**Question(s):**

- a) Please confirm the GLA Board Meeting on the 16<sup>th</sup> of June 2010 (or similar) did not go ahead?
- b) Please provide copies of minutes of meetings for the Worker Representative Liaison Group Meeting on the 9<sup>th</sup> June 2010, Labour User Liaison Group Meeting 20<sup>th</sup> May 2010, Labour Provider Liaison Group meeting 26<sup>th</sup> May 2010. These would be the fourth meetings of their groups.
- c) Please also provide the fifth meetings of the groups as per section b.

**Response:**

- a) We refer you to our previous FOI response 22-23 06 in which we said “There were no Board meetings between those on 21 April 2010 and 25 November 2010. You will see they are consecutively named ‘twenty-sixth board meeting’ and ‘twenty-seventh board meeting’.”
